Pools decreased \$14.4 million, short term no activity, agencies there were no activity. Total Portfolio decreased \$14.7 million to an ending balance of \$331.6 million. On July 31, 2018 the Yield was 1.86 percent, and the WAM was at 355.

There was a session last week regarding this project that included ten other colleges. Dr. Giovannini mentioned there were several highlights of this meeting but the best one was being told by the coaches, that TCC has made the most progress than any of the ten colleges present who are involved in the project. The Pathways is very much connected to the principles it's interwoven. The Chancellor mentioned that a couple of his monthly activities speak to being engaged with the community. He sees this brings an awareness of what TCC does, an understanding of what we do and more importantly an awareness and understanding of the challenges and barriers that our students have.
