- **H)** I am married to a person who has established and maintained domicile **in Texas** for at least 12 months prior to the next term of enrollment (provide a Marriage Certificate or Declaration of Registration of Informal Marriage with documentation to support that spouse has established and maintained domicile **in Texas** for 12 consecutive months prior to the census date of the term in which the person enrolls)
