Meeting of the Board of Trustees February 23, 2017 6:00 p.m.

- 1. <u>Call to Order.</u> The Board of Trustees conducted its regular monthly meeting on Thursday, February 23, 2017 in the District Offices, May Owen Center, with Mrs. Louise Appleman presiding. Other trustees present were Mr. O.K. Carter, Mr. Bill Greenhill, Ms. Teresa Ayala, Dr. Gwen Morrison, Mr. Conrad Heede and Dr. Diane Patrick. Also present were Chancellor Giovannini and members of the TCCD staff.
- 2. <u>Public Comment.</u> Mr. Kenith Cortez a student and employee at NW campus spoke briefly over two articles published in the Collegian newspaper regarding Immigrant Student Inclusivity and the advertisement services by Breitbart News Website in the Collegian newspaper. Mr. Cortez feels that TCC should take a stand and identify itself as a sanctuary school if even as a symbolic gesture, he feels that it would show respect for all students and "foster education in students of all backgrounds". Mr. Cortez also expressed his thoughts regarding TCC allowing Breitbart News Website to publish their services in the Collegian newspaper.

- 6. <u>Presentation on Student Access and Success and Administration Programs and Projects.</u> South Campus "Active Learning on TCC South Campus".

On behalf of the South Campus, President Peter Jordan introduced Dr. Dana Grove, Vice President of Academic Affairs, to discuss various ways that the South Campus is implementing active learning strategies into the classrooms. Mr. Carlos Rovello, instructor of History and Government, discussed some of his active learning classroom strategies and invited a number of his students to tell the Trustees what they learned in his classes

Dr. Morrison mentioned for the record that she has asked to have staffing in place at this facility to assistant anyone coming into the building with any questions regarding TCC without having to send them to a different building.

On a motion by Mr. Greenhill, seconded by Mr. Heede, the agreement was approved 6-1, with one abstention- Ms. Ayala.

 - On a motion by Mr. Heede, seconded by Dr. Patrick, the agreement was unanimously approved.
- 15. Consideration and Approval of BuyBoard Cooperative Agreement with Environmatic Systems to Provide Equipment and Installation to Upgrade Building Automation Systems to Reliable Controls for Criminal Justice Building on Northwest Campus. Amount \$206,391.62.
 - On a motion by Mr. Greenhill, seconded by Mr. Heede the agreement was unanimously approved.

- 18. Consideration and Approval of Contract with Integrated Computer Solutions for an Integrated Public Safety Solution. Amount \$319,819.00 (Not to Exceed).
 - On a motion by Mr. Heede, seconded by Ms. Ayala, the contract was unanimously approved.
- 19. Monthly Financial Report. Dr. McClendon, vice chancellor of finance, reported on revenues greater than 50%. Total revenue was slightly above last years, which was 67 percent and right now it is at 71 percent. There are no expenses greater than 50 percent and not discussed already as a pre-paid or BPO to discuss at this time. Over all expenses are at 48 percent with an actual of 42 percent and are within range. Increase in investment pools of \$49, 334,437 and purchased two \$20 million short terms with an increase total of \$40 million. US Securities, one matured at \$10 million for the federal national mortgage association. Another \$10 million was purchased from the federal farm credit bank given us a total balance of 110.7. Total portfolio 349.7. Yield spread of .24 percent, total investment portfolio of .90 percent, tbill of .665 percent and WAM is 325 versus 365 due to us receiving more funds in the month and pushing that number down.

20. Board President's Report.

- a. Ms. Appleman mentioned that some of the board members, faculty and staff will be participating in a rotary club literacy reading initiative, which they'll be judged on. Other groups have been involved with City's Literacy reading project near the Southeast community.
- b. Ms. Appleman reported that she attended the North Texas Specialty Physicians Job Training Grant Check presentation at Tarrant County College Opportunity Center on Friday, January 20, 2017.
- c. Mr. Conrad Heede/Mr. Bill Greenhill reported that they attended Community College Day in Austin, Texas on February 7, 2017 along with several TCC students. The trustees are actively involved in advocating for the best interests of community colleges and in the interests of the students. This year the state will be receiving 4 percent less funding than normal and only .04 percent was cut for community colleges, which the legislatures are very aware how important community colleges are for students.
- d. Board of Trustees Dr. Patrick, Mr. Greenhill and Ms. Ayala spoke about attending the ACCT National Legislative Conference trip in Washington, D.C. February 13-16, 2017. Dr. Patrick mentioned that this was her first opportunity to attend this conference on behalf of TCC. Dr. Patrick found it very rewarding speaking with several of our state representatives and their understanding of the community college needs. Mr. Greenhill spoke briefly on the Pell Grant system. Ms. Ayala mentioned that besides seeking support on the Pell Grant, they also asked them to consider in assisting the North Texas region with any infrastructure opportunities to help bring jobs here that would help boost the economy as well as help our students get jobs.
- e. Dr. Morrison invited everyone to attend the Diversity and Inclusion event with guest speaker Mr. Hermon Boone event on Tuesday, February 28, 2017 at the Hurst Conference Center. Also the invitation was extended to view the student paintings hanging in the Rotunda at TR campus.

- f. Mr. Greenhill thanked Dr. Madison for hosting an event called Third Good Marshall where he took students to dinner and a play and had a Q&A session with Mr. Greenhill and each other.
