Chancellor Erma Johnson Hadley
1968-2015

History and Biographical Notes

Erma Johnson Hadley was Chancellor of Tarrant County College from 2010 to 2015. She was born and raised in Leggett, Texas and was the first black student there to graduate from college. She earned a Bachelor's degree from Prairie View A&M University and an MBA from Bowling Green State University. Hadley's first teaching position was with Turner High School in Panola County. In 1968, she became a founding member of the faculty of the Northeast Campus of Tarrant County Junior College, later Tarrant County College. She was named interim chancellor of TCC in 2009 and became chancellor the following year.

Hadley served on numerous boards and commissions. She was the first woman named to the Dallas/Fort Worth International Airport Board and the first African American to serve as the board's chair. She was very active in community service work, including the Links, a national organization for African American women, and the Texas Association of Black Personnel in Higher Education. She served on the Board of Trustees of Paul Quinn College.

Hadley died at the age of 73 after suffering from pancreatic cancer.

As far back as the mid-1920s, the city of Dallas suggested joining forces with the nearby city of Fort Worth to create a jointly managed airport. However, Fort Worth was keen to pursue its own interests and soon opened its own Meacham Airfield, and so Dallas chose to develop its already existing Love Field Airport.

However, in 1940, a site was chosen within the city of Arlington, strategically sited between both Dallas (east) and Fort Worth (west). However, due to many disagreements, it was not until 1974 that the Dallas Fort Worth International Airport (DFW) was finally opened, after a new site was selected north of Arlington and close to Irving. This was the world's biggest and most expensive airport at that time.

The Housing Authority of the City of Fort Worth was created on January 5, 1938 by the Fort Worth City Council in response to federal legislation (U.S. Housing Act of 1937) that enabled the 45th Texas Legislature (1937) to charge local entities with providing decent, safe and sanitary housing for low to moderate income families and individuals. At that time, the mayor of Fort Worth appointed the first Board of Commissioners. That tradition continues through today as Fort Worth mayors continue to appoint new commissioners to the board as needed.

Ripley Arnold Place and Butler Place were the agency's first two public housing communities, opening their doors in 1942. In the early 1950s, as public housing began to change from housing for the working class to the long term poor, J.A. Cavile Place was added to the housing authority's inventory. As housing needs continued to expand, Ripley Arnold and Butler experienced residential additions in 1962 and 1963.

John Peter Smith Hospital
Board of Managers

In October 1877, future Fort Worth mayor John Peter Smith deeded five acres of land at what is now 1500 South Main Street to provide a place where individuals from Fort Worth and Tarrant County "could have the best of medical care." It would be many years before his vision for a facility on that location would be realized, but not so long before the first public hospital for the community was established.

In 1906, a hospital affiliated with the Fort Worth Medical College was opened in Fort Worth free to all accident cases and any other cases which the authorities will accept, and the foundation for JPS Health Network was laid. Seven years later, county commissioners agreed to match city funds for the operation of a city and county hospital, which soon opened with 25 beds.

By 1938, the downtown location was well past adequate for the demands of the region, and construction of the new hospital, on the land donated by John Peter Smith, began. The 166-bed City-County Hospital rose to many challenges, including the polio epidemic, and served as the main trauma center for Tarrant County.

In 1954, the name of the hospital was officially changed to John Peter Smith Hospital, and in 1959 the Tarrant County Hospital District was created to give the organization a sound financial footing.

North Texas Commission

On July 29, 1971, a group of civic leaders from across North Texas joined together to form the North Texas Commission (NTC), an agreement which would change the course of history in our region. It was agreed that a regionally-unifying force was necessary. A unique vision of a regional marketing organization for the entire North Texas area. C.A. Tatum, Jr., the first volunteer leader of NTC, often remarked, "Our strength is the spirit and unity of the people of our region."

The North Texas Commission was chartered as a non-profit, membership-supported organization which would work to unify the North Texas Region to maximize the visibility of the area as an excellent place to live and do business. In February of 1972, NTC copyrighted the term "Southwest Metroplex," which users later shortened to simply "Metroplex," in order to establish the identity of the allied communities of North Texas.

On April 7-9, 1973, several representatives of state and private institutions of higher education, within and outside the State of Texas, met at the Ramada Inn Central in Dallas, Texas, to discuss concerns pertinent to the well-being of African Americans at higher education institutions in the state of Texas.

It was determined that because all in attendance served in various specialized positions within these institutions with a commitment to equal opportunity and affirmative action efforts in higher education, that we formally organize an association to promote, maintain and assure the development and growth of African Americans in the educational process.

Under the leadership of those who served as president of the state organization, for the more than 25 years following this action, hundreds of African-American leaders have acted as a unified force to address new and recurring challenges in Texas higher education.
