***Terms of Use***

The licensed materials (content) in the Tarrant County College (TCC) Digital Archive Repository includes digital images, text, videos, and audio recordings of historical items being made available by the Tarrant County College Archives for use in research, teaching, and private study.

**Copyright**

While a good percentage of these historical materials are in the public domain, the mere nature of archival collections often makes it difficult to determine the copyright status of an item. Some materials in these collections may be protected by U.S. Copyright Law (Title 17, U.S.C.).

Individuals are therefore encouraged to contact the TCC Archives for information regarding copyright status of a particular item. The TCC Archives staff will provide any information it has available to aid an individual in determining the copyright status of an item. However, it is ultimately the responsibility of the individual to determine copyright status and utilize items in the repository within the terms that govern their use. Copyright owners who may not be properly identified are also encouraged to contact the TCC Archives staff so their information can be documented and provided in the future.

**Terms of Use**

By using these digital images, texts, videos, and audio recordings the individual understands and agrees to abide by the following terms of use. Specifically, you the individual who wishes to use these digital materials:

- Understands responsibility for any use of these materials rests exclusively with you the individual,
