## *Who are our students?*

For purposes of this report, all 2023 Fall TCC undergraduate students were considered. For each campus, a student was defined as any student who took at least one course at that campus in 2023 Fall. First time in college (FTIC), Transfer In, First Generation, Veteran, and Men of Color students are all subsets of students. *(New student orientation (NSOR) and adult education (AE) - credit type "N" - course enrollments were removed.)*

**Undergraduate:** any student who took an undergraduate level class in 2023 Fall at TCC. This included students enrolled in developmental education. However, credit type "N" were not included.

**First time in College (FTIC):** a first time in college student who is not in dual credit and not auditing courses.

**Transfer In:** students who have taken coursework at other postsecondary institutions.

**First Generation:** a student whose parents did not attend postsecondary education.

**Veteran:** defined by the student's indication of veteran status on his/her application and does not include veteran dependents.

**Men of Color:** male students who identified as Black/African American, Hispanic Latino, Asian, American Indian/Alaska Native, Native Hawaiian/Pacific Islander, or Multiracial.

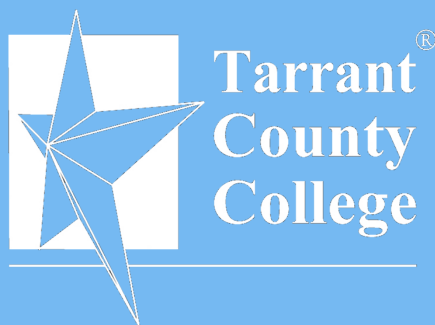
