## Paramedic Programs and Application Procedures

---

The Emergency Medical Services Program at Tarrant County College was instituted in 1974 as the first EMS training site in Tarrant County. The program began teaching two EMT courses and one Paramedic course each year. Since then, we have grown to offer eight EMT courses and teach up to three paramedic courses at one time, all at different stages of completion. In 1998 the EMS Program earned National Accreditation from the *Commission on Accreditation of Allied Health Education Programs*, becoming the 7th program in Texas to achieve such status. Today our graduates are highly desired employees and have a first-time pass rate on the National Registry exam of 95%, which is among the top 5% of schools in Texas and the top 10% of schools across the nation.

The EMS Program is a selective admissions program. Two schedules are offered for the Paramedic Programs, each starting at a different time of the year. The Paramedic Program can be taken either as an AAS Degree or Certificate. You must have your Texas EMT certificate before you start your Paramedic course.

**Shift-Based Day Program (Fall):** The course is limited to 24 students.

The program starts each **Fall semester in late August**. Classes meet at the TCC EMS Satellite Campus at the City of Fort Worth Bob Bolen Public Safety Complex on fire department **B shifts, Mon. through Sat. (rotating two days per week), from 8 am to 5 pm for 12 months**. Students enrolled in this program must have a schedule that allows them to attend on a **one day on/two days off** rotation. The application deadline for the **Fall 2024** program is **June 6, 2024**. The application deadline for the **Fall 2025** program is **June 5, 2025**.

**Shift-Based Day Program (Spring):** The course is limited to 24 students.

The program starts with each **TCC Spring semester**. Classes meet at the TCC EMS Program Satellite Campus at the City of Fort Worth Bob Bolen Public Safety Complex on fire department **A shifts, Mon. through Sat. (rotating two days per week), from 8 am to 5 pm for 12 months**. Students enrolled in this program must have a schedule that allows them to attend on a **one day on/two days off** rotation. The application deadline for the **Spring 2025** program is **October 10, 2024**.

### **Shift-Based Day Program Rotating Schedule Sample:**

Week 1 = Monday & Thursday, 8 am – 5 pm

Week 2 = Tuesday & Friday, 8 am – 5 pm

Week 3 = Wednesday & Saturday, 8 am – 5 pm

### Applying to the Paramedic Program

- Obtain **all** official transcripts from **all** colleges attended. Withholding transcripts will result in immediate disqualification. If you have less than 12 college credit hours completed, you must submit your high school transcripts for evaluation.
- If not already completed, submit an application to **Tarrant County College** to be enrolled as a credit student. This can be done by applying online at [www.tccd.edu/apply](http://www.tccd.edu/apply). This will require the submission of official transcripts from high school and/or from all colleges attended. You must be accepted by TCC before being accepted by the EMS Program.
- Following all instructions at [tccd.college/paramedic](http://tccd.college/paramedic) (“How to Apply” page), submit your application online to the **Paramedic Program**. This will require:
  1. The submission of official transcripts from all colleges attended (*including TCC*), and
  2. The submission of a copy of a **Texas EMT certification** issued by the Texas Department of State Health Services. **We CANNOT accept a National Registry EMT Certification!**

Within three weeks following the application deadline date, you will be notified of a General Information Meeting. This meeting will explain the specifics of the program you have selected and will give applicants one last opportunity to make sure the selected program meets their needs. An invitation to this meeting does not guarantee program selection; however, attendance is mandatory for program consideration.

Once selected to the Paramedic Program you will be required to pass a national criminal background check and drug screening. You will also be required to show completed immunizations as stated by the Texas Administrative Code, which includes the Hepatitis B series. The Hepatitis B series consists of 3 injections taking 7 months to complete. If this series is not completed, you are **not eligible** for selection into the program.

People's lives often depend on the quick reaction and competent care of emergency medical technicians (EMTs) and paramedics. EMTs and paramedics are the special forces of medicine, providing vital care to patients in emergency situations. These professionals work anywhere and everywhere, often in uncontrolled environments, to provide pre-hospital care in critical moments. The Tarrant County College Emergency Medical Services (EMS) Program is designed to train students to provide fast and efficient emergency medical care of the sick and injured, both at the scene and during their subsequent transport to the hospital. Paramedics and EMTs respond to emergency medical calls. They enter the patient's environment and must quickly assess the situation and define a course of action. To be successful these professionals must demonstrate:

- excellent communication and leadership skills
- strong math and science background
- good physical conditioning
- sound judgment and problem solving skills
- the ability to work well on a team and under pressure
- a desire to provide the best medical care possible to all patients
- a high level of ethics and morals

Admission to the certificate and associate degree programs is limited. Prospective students must complete an Application for Admission to the Selection Committee for EMS & Dental Hygiene Programs each application period (Fall, Summer and/or Spring) to ensure consideration for admission into the program. # Specialized admission is required for the following classes which constitute the "Advanced or Paramedic Program" (EMSP 1355, EMSP 1356, EMSP 1438, EMSP 2160, EMSP 2161, EMSP 2162, EMSP 2243, EMSP 2305, EMSP 2267, EMSP 2430, EMSP 2444, EMSP 2534 & EMSP Elective). The remaining courses for the EMS degree are open to all students.

**A selection committee reviews applications and selects those applicants who best meet the following criteria (listed in random order):**

- Students must meet TSI requirements (reading/writing, algebraic math) for credit course enrollment.
- Grade point average (GPA) of all high school or undergraduate college classes.
- GED scores if high school/college are not applicable.
- Bonus points for college-level general education and science courses required for the program for which a grade of C or higher was made. NOTE: Science courses must have been completed within five years of the semester containing the program deadline date.

Bonus Points are earned for any of the 8 non-EMSP courses completed prior to the application deadline date. Non-emergency medical services courses (courses listed in this degree plan NOT beginning with prefix letters EMSP) earn **0.10 bonus point**, each course, if completed with a C or better.

<sup>^</sup>Exceptions are the science courses in this degree plan – **BIOL 2401 and BIOL 2402.**

Completion of these science courses earns bonus points based on grade. **A=0.30, B=0.20, C=0.10.**

**A student completing bonus point classes prior to the application deadline with a high GPA will be most competitive when applying. Courses earning bonus points are shown above, shaded in gray.**

Only the criteria listed are evaluated and considered for the purpose of selection and admission to this program. No specific minimum grade point average or test score, or a set minimum number of courses must be completed for admission. Selection is based on how each applicant compares with others in the applicant pool. In general, the higher the grades, the more competitive the applicant will be for the positions available.

- Students must meet TSI requirements (reading/writing, algebraic math) for credit course enrollment.
- Grade point average (GPA) of all high school or undergraduate college classes.
- GED scores if high school/college are not applicable.
- Bonus points for college-level general education and science courses required for the program for which a grade of C or higher was made. NOTE: Science courses must have been completed within five years of the semester containing the program deadline date.

Bonus Points are earned for any of the non-EMSP courses completed prior to the application deadline date (see degree plan). Non-emergency medical services courses (courses listed in the associate degree plan NOT beginning with prefix letters EMSP) earn **0.10 bonus points**, each course, if completed with a C or better.

^Exceptions are the science courses recommended for this certificate plan – **BIOL 2401 and BIOL 2402**. Completion of these science courses earns bonus points based on grade. **A=0.30, B=0.20, C=0.10.**

# Paramedic Program Application Checklist

You are responsible for making sure you have met **all requirements** and for submitting all necessary documentation with your Paramedic Program application.

## When you apply:

\_\_\_\_ **TCC ID Number:** You must [apply to TCC](#), be accepted as a student and get a TCC Student ID number.

\_\_\_\_ **TSI Requirements:** You must meet the [TSI requirements](#) for enrolling in college credit courses.

\_\_\_\_ **Texas EMT Certification:** You must submit a **current copy of your Texas EMT Certificate** with your application.

\_\_\_\_ **Official Transcripts—2 copies:** You must submit 2 copies of your transcripts from all the colleges you have attended: 1 copy with your online paramedic application and 1 copy to the TCC Registrar's office.

**International Students:** Contact International Admissions (817-515-1570) if you have international transcripts.

## After you are accepted:

### \_\_\_\_ **TCC Health Form, Completed and Signed by a Physician**

You **cannot start** our program without **proof of all** immunizations. Texas Administrative Code (TAC) requires all students in health-related programs to be immunized prior to enrollment in classes where patient contact is a component.

- **Required vaccines:**

- **Tetanus/Diphtheria/Pertussis: 1 dose**, as an adult within this past 10 years.
- **Varicella (Chicken Pox):**
  - 1 dose if given before the age of 13
  - 2 doses if given after the age of 13 (6 weeks to complete)
  - History dates of the disease are not acceptable—only titer test or vaccination dates will be allowed
- **Measles, Mumps, Rubella / MMR: 2 doses required or**
  - Measles: 2 doses required
  - Mumps: 1 dose required
  - Rubella: 1 dose required
- **Influenza:** 1 dose required, current season
- **Meningococcal Meningitis:** 1 dose required
- **Hepatitis B:** 1 series of 3 doses required (commonly takes 7 months to complete)
  - The 3-dose series will need to be complete, or immunity will need to be proven through titer testing, **before the first day of class** in order for you to be able to participate in the upcoming semester's program. Only the 3-dose series is accepted.
  - The accelerated series Twinrix® is not an acceptable option.
- **Covid-19:** EMS Program clinical sites currently RECOMMEND but do not require that EMS students be vaccinated for COVID-19. If clinical sites should make changes to again require the COVID-19 vaccine to attend clinical rotations, non-vaccinated students may not be able to complete the clinical rotations necessary to successfully complete EMS courses.

- **Required screening:**

- Tuberculosis Test: within 1 year of start of program

\_\_\_\_ **CPR Certification:** You are required to have a current American Heart Association Healthcare Provider CPR Certification, issued within the last year.

\_\_\_\_ **Health Insurance:** You are required to submit proof of health insurance when doing clinical coursework. TCC does not offer College- sponsored student health insurance.
