ARTICULATION AGREEMENT

Between

Tarrant County College and Collin County Community College District

This Agreement is made and entered into between Tarrant County College (Tarrant), a local government entity, and Collin County Community College District (Collin College), a local government entity.

This agreement becomes effective upon the date of final signature and shall apply for students transferring from Tarrant to Collin College beginning the subsequent semester

A. Purpose of Agreement

The purpose of this Agreement is to enable Tarrant students who successfully complete the A.A.S. degree in Cybersecurity and articulated courses as outlined in this Agreement (see Appendix A) to transfer to Collin College in a seamless transition toward the completion of the Bachelor of Applied Technology in Cybersecurity (B.A.T.) degree. The degree plan attached lists CYBR upper division courses and prerequisites that are required along with core course suggestions for completing the academic core.

B. Terms of Agreement

1. Responsibilities of Collin College:

Collin College hereby agrees as follows:

- a) To accept the coursework as outlined in this agreement for those Tarrant students who have earned a GPA of 2.0 or higher. This coursework will comprise the first 54 hours of the B.A.T. degree. Transferring students will be required to take six hours of designated lower division coursework in Cybersecurity at Collin to attain the necessary skills for advanced work.
- b) To develop and provide materials related to a seamless transition to the bachelor's degree program, in cooperation between Collin College and Tarrant. Tarrant students will be conditionally admitted to Collin College's Cybersecurity program, contingent upon taking the designated six hours of lower division coursework within their first academic year at Collin College.

- c) To post on the Collin College website the articulated Collin College/Tarrant 2+2 pathway.
- d) To provide and teach courses articulated in this Agreement.
- e) To provide Tarrant advisors with information and support in helping them with their role of assisting Tarrant students with transfer and degree program advising.
- f) To provide Tarrant students with scholarship and financial aid information through admission and advising material.

2. Responsibilities of Tarrant:

Tarrant hereby agrees as follows:

- a) To provide Tarrant students with Collin College course listings for this program through bulletin and web postings, advising materials, and other appropriate media.
- b) To provide recruitment opportunities at all campuses.
- c) To continue to teach the courses and offer the associate degree in the attached pathway.

3. Responsibilities of Both Institutions:

- a) A program review will occur annually to assess the current performance of the program and consider future modifications.
- b) Each institution will award degrees and admission into degree programs in accordance with its established rules.
- c) Each institution will maintain accreditation by the applicable accrediting authority.

C. Course Delivery

Each institution agrees to offer courses as outlined in the Articulation Degree plans (see Appendix A). Because of possible changes in degree requirements imposed by the state and program modifications and changes that occasionally occur, Tarrant students transferring to Collin College must follow Tarrant, Collin College, Texas Higher Education Coordinating Board and Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) policies regarding degree program criteria.

D. Term of Agreement

This Agreement shall be in effect for a period of five years after the date of the last signature. It may only be modified, except in the appendices, by a written agreement signed by authorized officials of both institutions. The Agreement will operate as a commitment for each cohort admitted to Collin College for this degree pathway.

E. Termination

Upon implementation, this Agreement will continue on an annual basis until one of the party's petitions, in writing, the other party to end this Agreement. This Agreement will be reviewed jointly on an annual basis and updated as necessary.

Such petition to end this Agreement: 1) must be submitted one-year in advance of the intent to terminate; 2) must be submitted in writing and signed by the college/university president making the petition; 3) must be delivered to the second party to the Agreement. Delivery of the intent to terminate will constitute formal notification and will serve as grounds for termination one-year following the date of delivery.

F. Governing Law and Venue

The parties agree to use mediation as the first resort to resolve conflicts related to this agreement. If a legal action is instituted or a claim is filed in connection with any dispute arising out of or related to this Agreement, the parties agree that jurisdiction and venue for such disputes will be either: (a) in a state district court located in Collin County, if the legal action is filed by Collin College, or (b) in a state district court in Tarrant County, if the legal action is filed by Tarrant.

G. Amendments, Changes, or Modifications

No amendment, change, or modification to this Agreement, except for specific pathway modifications in the appendices, may be made without formal written agreement of both parties.
