A limited number of need-based dual credit grants are available for high school dual credit courses. TCC Student Financial Aid Services determines eligibility based on completion of a Free Application for Federal Student Aid (FAFSA) (www.studentaid.gov) and Dual Credit Enrollment Grant application. The grant assists with tuition and book expenses for up to four semesters (up to 6 credit hours per semester not to exceed 12 credit hours per academic year for a maximum of 24 credit hours) at Tarrant County College.
